This venue has space for a competition dance floor and a warm-up floor. The Closing Dance Gala will be organized at the same venue.

- 25 x 15 meter (375 square meter) parquet competition dance floor.
- Parquet warm-up floor, next to the competition floor.
- Competition floor (250 athletes).
- Spectators area in the stands (up to 500 spectators).
- Locker room area (wheelchair-accessible).
- Scoring area.
- Area for judges and the organization.

- Area where participating athletes can get changed.
- · Locker room for participants.
- Area for commercial stands related to dance.
- · Restaurant inside the venue itself.

The FBECV organizes different local, regional and national competitions throughout the year (standard, Latin, single, choreographic dance, Caribbean dances, hip hop, breakdancing, etc.).

A Gala Ball will be held in the evening on the last day of the competition (ticketed event).

### 5.2 Categories/Divisions

There will be two age groups: Open (18+) and Senior (45+) competing at each of the following levels:
•Class "A" (top level): Waltz, Tango, Viennese Waltz, Slow Foxtrot, Quickstep, Cha Cha, Samba, Rumba, Pasodoble, Jive, Line Dance

•Class "B" (advanced level): Waltz, Tango, Slow Foxtrot, Quickstep, Cha Cha, Samba, Rumba, Jive, Line Dance •Class "C" (intermediate level): Waltz, Tango,

Quickstep Latin: Cha Cha, Rumba, Jive, Line Dance
•Class "D" (beginner level): Waltz, Tango, Quickstep,
Cha Cha, Rumba, Jive, Line Dance

•Class "E" (optional and for dancers who are at a prebeginner level and have not danced in any competition previously): Waltz, Quickstep, Cha Cha, Rumba, Line Dance

•International 10-Dance: Open General, Open Women, Senior General, Senior Women

•Showdance: Open to everyone 18+ years old regardless of gender

•Team Formation: Open to everyone 18+ years old regardless of gender

•Wheelchair dance: Women's and General divisions
•Line Dance: team category open to everyone 18+
years old regardless of gender, individuals may
compete within their class & age group

## 5.3 Scheduling (number of days, etc.)

5 days (4 days of competition plus the dance gala).

### 5.4 Number of competitive instances per athlete

A registered participant may dance with different partners in different categories. A couple may enter multiple categories, but not multiple class levels.

A couple may always dance in a lower age category, if offered, in addition to its own age category.

A team may only enter one category.

### 5.5 Total number of competitive instances

It will depend on the number of registered participants.

## 5.6 If the event is ticketed, how will tickets be sold, distributed, and collected?

Tickets are managed through a pre-sale application to be picked up at the door.

## 5.7 Is sport-specific sponsorship possible for this event?

It is possible. We will be exploring various options as we move towards hosting the event.

## 6.1 How will you address requirements of Policy guidelines for Age and Ability?

Two age divisions, as per the requirements of IFSSDA's competition rules. Multiple ability divisions.

## 6.2 How will you address requirements of Policy guidelines for Disability?

The requirements of the Red Book regarding disabilities are met, since the facility's accessibility is suitable for people with functional diversity and, in terms of sport, there is a specific category for them. Wheelchair divisions may be created.

## 6.3 How will you address requirements of Policy guidelines for Gender in Sport?



A women-only category and a general category is proposed. The gender in the competition is as declared by the participant.

# 6.4 How will you address requirements of Policy guidelines for Health and Well- being, and in particular, Performance-Enhancing Drugs?

There will be a mobile health team that will be around the area for any emergencies. Athletes will be observed to ensure they comply with anti-doping regulations and have exemplary behavior.

## 6.5 How will you address requirements of Policy guidelines for Officials?


Each day requires two MCs, one chairperson, a team of scrutineers/technical managers, a team of DJs, a team of registrars, a team of helpers and a minimum of 7 judges/adjudicators per category (minimum of 10 available judges per day of different nationalities and both genders). Most of them will be volunteers and will be a mix of IFSSDA and FBDCV members. All FGG guidelines regarding the training, accreditation and recruitment of officials will be followed.
