





60% men, 40% women. In Spain, women's water polo has become significantly more popular. It is currently the 3rd most played group sport by women.

Miguel Vázquez Calvo - Sports Director and Coordinator of the València Region Swimming Federation (FNCV), together with the staff of said federation.

4.5* Will a local club be involved in the organization of the event?

All clubs with players who have a masters license from the region of València.

4.6 What local experience is available to the host in organizing competitions for this sport?

We are organizers of the RFEN technical conferences and of more than 5 simultaneous events per year (Valencian league with 6 different categories, 3 of which are mixed, national league matches, cups and trophies).

5.0 Organization of the Event

5.1 Description of tournament (seeding, rounds, etc.), relative to Red Book requirements.

The competition will meet the requirements of the Red Book.

5.2 Categories/Divisions

General senior, female senior and mixed senior categories.

Minimum of 5 matches, maximum according to the number of teams.

Maximum of 8 matches. It will depend on the registered number of teams.

It is possible. In fact, we will be exploring various options as we move towards hosting the event.

The swimming competition accepts all people 18 years and older, and all swimming levels.

The pool is fully adapted for people with disabilities.

We will offer the following competitions: women-only, general and mixed formats.
