# 2.5 Description of the facilities (spectator seating, locker rooms, warm-up areas, etc.)

The València Region Hockey Federation (FHCV) facilities have two hockey pitches, changing rooms, a gym, a cafeteria, bleachers and other sports facilities for all of its users to take advantage of. It is also warm in its welcoming of visiting teams.

2.6 Describe the venue with respect to the Red Book requirements. If the venue does not meet the Red Book requirements, what are your plans for dealing with this? The FHCV facilities comply with all the Red Book requirements in addition to having access for wheelchair-bound spectators.

The FIH Hockey Pro-League, the FIH Olympic Qualifier Valencia 2019 and the Eurohockey Junior Championship 2019 (Men and Women) are clear examples of some of the championships organized by the FHCV at these facilities, although they also host national league matches.

## 2.8 Why did you choose this venue?

To promote and raise awareness about field hockey. Because we have cutting-edge facilities that are prepared to host internationally-renowned events.

#### 2.9 If more than one venue will be used, what are the issues and solutions for this (transportation, communication, etc.)?

The València Region Hockey Federation has two hockey pitches located a 6 minutes' walk away from one another, meaning transport is not needed to go from one pitch to the other.

#### 5.0 Organization of the Event

5.1 Description of tournament (seeding, rounds, etc.), relative to Red Book requirements.

The competition will be conducted in acoordance with the Red Book requirements.

The competition will include two contests, one being competitive and the other recreational, both of which are split up into general and women-only categories. The following will be organized:

A preliminary round organized by groups.

A round of eliminations that will classify the teams.

#### 5.2 Categories/Divisions

The hockey tournament will have two divisions, one being competitive and the other recreational, with both of them having a general division and another for women only.

#### 5.3 Scheduling (number of days, etc.)

5 days from Sunday, May 31st to Thursday, June 4th 2026.

#### 5.4 Number of competitive instances per athlete

Each participant will have 5 matches guaranteed for them:

3 games in the preliminary round.

2 games in the disqualifying rounds.

#### 5.5 Total number of competitiveinstances

Depending on the number of participants and the type of play, the highest number of possible matches will be played while ensuring the 5 match minimum at all times.

# 5.6 If the event is ticketed, how will tickets be sold, distributed, and collected?

Not slated to be ticketed.

Divisions will be based on ability, not age.

Participation requires full mobility and good health. This sport is accessible for players with hearing disabilities and very slight vision impairments. There is no specific category for disabled people. The venue is wheelchairaccessible, and suitable accommodation will be provided for any spectators that require it.

A women-only category and a general category has been proposed.
