It is an open space venue with 18 courts for playing beach volleyball. We will arrange an area with a reception desk, water stations and porta potties.

The FVBCV hosts all the competitions in the region of València. They have the best expertise, having organized these kind of beach volleyball events in this facility since 2010.

5.0 Organization of the Event

5.1 Description of tournament (seeding, rounds, etc.), relative to Red Book requirements.

Doubles tournament: general and women's: 2 players on the court per team, no more than 2 on the roster. Mixed teams are allowed and will compete in the general division. The beach volleyball tournament will consist of preliminary rounds (pool play) and single elimination rounds

General tournament with the following categories: A, BB, B, & C divisions.

Women's tournament with the following categories: A, BB. B. & C divisions.

4 days

It will depend on the number of teams registered.

The event is not slated to be ticketed.

It is possible. In fact, we will be exploring various options as we move towards hosting the event.

6.1 How will you address requirements of Policy guidelines for Age and Ability?

Competition will be subject to age and ability divisions.

6.2 How will you address requirements of Policy quidelines for Disability?

Participation in this sport would be difficult for people with most levels of disability. This sport is not accessible to wheelchair users. However, reasonable accommodations will be offered for spectators who need them.



6.3 How will you address requirements of Policy guidelines for Gender in Sport?

Standard policy applies. There could be a difference in the height of the nets among the different divisions that will be controlled.

One full medical team will be on call for the whole tournament. All policies for health and well-being, including the use of performance-enhancing drugs, will be adhered to.
